GUIDELINES:

The *Fright Night* competition parameters are:

- General
 - 1. Teams: 1-4 cosmetologists (max).
 - 2. Team competitors must register with their own provincial Association
 - (Cosmetology Association NS or NB) for the *Fright Night* competition no later than 4:30 p.m. on October 1, 2025.
 - 3. All team competitors must possess a current/valid cosmetology license for entry into the competition.
 - 4. Each team must bring their own model (one model only). Models must be 18 years of age or older.
 - 5. Competitors must provide their own product, implements, and equipment. Stations (a table, mirror, chair, and plug-in for thermal equipment such as curling or flat iron, hairdryer, etc.) will be provided by the Cosmetology Associations (NS & NB).
 - 6. Competitors and their models must arrive promptly for check in. Any competitor that arrives late will be disqualified. (Registration fees are non-refundable.)
 - 7. Cell phones, iPads, iPods, MP3 players, and other electronic devices are **not** permitted on the competition floor.
 - 8. Only competitors and models will be permitted in the preparation areas.
 - 9. Sanitation procedures: a submersible disinfection unit, hand sanitizer, and other sanitation products must be readily available and used. Competitor teams must provide their own bin for used disposables, garbage, etc. (plastic bags are not permitted).

- 10. Health and safety procedures and standards must be adhered to throughout the competition.
- 11. All competitors and models are required to sign a release and waiver that will include (but is not limited to) the following:
 - Confirmation that all chemical testing and product allergy testing was completed before the Event.
 - Acknowledgement that the Cosmetology Associations (NS & NB) may post competition and Event photos to social media and websites.
 - Acknowledgement that any damage to hotel property resulting from color, make-up, etc., will be the responsibility of, and will be charged to, the competitor team and not the Cosmetology Associations (NS & NB).

Cosmetologists Unite Event coordinators reserve the right to cancel any competition that has less than five registered Teams. In the event of cancellation, competitors will be notified by phone or email no later than two (2) weeks prior to the Event competition and a refund will be issued.

- Pre-Prep
 - All dress, make-up applications, lash extensions and nail enhancements must be completed in advance of the competition (competitors will be permitted to complete touch-ups during the last 30 minutes of the competition.)
 - Equipment, products, and wardrobe promotion of a specific product line is not permitted.
 - Team models must be seated, posed, and remain in the same position for the duration of the judging process (15 min. max.)

Frightful Look

- > Hair can be any length, texture, or colour.
- > Any chemical/colour application must be completed prior to the competition.
- Finished (hair) is not to exceed 4' in height.
- > Teams must incorporate a minimum of 2 braids in the finished look (hair).
- Extensions, hairpieces, and any addition of accessories must not cover more than 50% of the head (50% of the natural hair must be visible for judging).

(*Note*: any accessories/additions to a model's natural hair may be created prior to the competition/Event weekend.)

JUDGING CRITERIA

- Teams will be judged on overall creativity, originality, and finished look (to include attire), that is consistent with a *frightful* theme. Judges will focus on quality, technical skill, and overall attention to detail, and workmanship.
- Must illustrate a *frightful theme* with appropriate coordination of colour, balance, and complexity.
 - ➢ 50% Hair design.
 - > 25% Make-up, lashes and nails.
 - > 25% Overall finish consistent with a *frightful* theme.
